KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **Ten and 00/100 Dollars (\$10.00)** and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, **The Sole Heirs at Law and Next of Kin of Lois B. Harrison, deceased**, hereinafter called "Grantor," does hereby GRANT, BARGAIN, SELL AND CONVEY unto **Myra K. Lucas, a married woman**, hereinafter called "Grantee" in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County**, Alabama, to-wit:

Commence at a 2-inch capped pipe locally accepted as the Southwest corner of the Northwest Quarter of the Southeast Quarter of Section 8, Township 24 North, Range 12 East; thence South 89 degrees 06 minutes 59 seconds East along the South line of said 1/4-1/4 Section and run 535.62 feet to a 1/2-inch rebar; thence continue South 89 degrees 07 minutes 49 seconds East and run 343.03 feet to a 5/8-inch rebar and also the Point of Beginning; thence continue South 89 degrees 07 minutes 49 seconds East and run 49.90 feet to a point; thence North 34 degrees 25 minutes 31 seconds East and run 187.82 feet to a 5/8-inch rebar; thence North 64 degrees 29 minutes 05 seconds West and run 24.92 feet to a 5/8-inch rebar; thence South 39 degrees 00 minutes 54 seconds West and run 212.15 feet back to the Point of Beginning.




