WARRANTY DEED

## KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One and no/100 Dollar (\$1.00) and other good and valuable consideration to the undersigned Grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, Jeanette Kendrick, a married woman, Darlene Calfee, a married woman, Keith E. Cox, Sr., a married man, Lesley Wayne Cox, a married man, and T. W. Blackstock, a widower (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto Jeanette Kendrick, Darlene Calfee, Keith E. Cox, Sr., and Lesley Wayne Cox (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Part of the SE 1/4 of the NW 1/4 and part of the NE 1/4 of the SW 1/4 of Section 22, Township 20 South, Range 3 West, in Shelby County, Alabama, and being more particularly described as follows: Commence at the Southeast corner of the SE 1/4 of the NW 1/4 of Section 22, Township 20 South, Range 3 West; thence run West along the South line of said 1/4 - 1/4 Section for 652.67 feet; thence 89 degrees 18 minutes 42 seconds right and run North for 33.41 feet to an old iron pin found in place, said point being the point of beginning; thence 121 degrees 21 minutes 06 seconds left and run Southwesterly for 200.0 feet; thence 89 degrees 04 minutes right and run Northwesterly for 132 feet; thence 93 degrees 31 minutes 39 seconds right and run Northeasterly for 256.59 feet; thence 111 degrees 38 minutes 21 seconds right and run Southeasterly for 132.00 feet to the point of beginning. Said tract contains 0.6644 acres, more or less and is shown as BLOCK NO. 6 of Frank E. "Buck" Cox Property, recorded in Map Book 8, Page 21, in the Probate Office of Shelby County, Alabama, including an easement for ingress, egress and utilities to BLOCK 6 from Roy Drive, said easement being shown on map of Frank E. "Buck" Cox Property, recorded in Map Book 8, Page 21, on July 30, 1980, in the Probate Office of Shelby County, Alabama.

The above described property constitutes no part of the homestead of any of Grantors herein.

It is intended to and is conveyed hereby any and all interest in all real estate owned by Josie O. Cox at the time of her death located in Section 22, Township 20 South, Range 3 West, Shelby County, Alabama, whether correctly described herein or not.
