

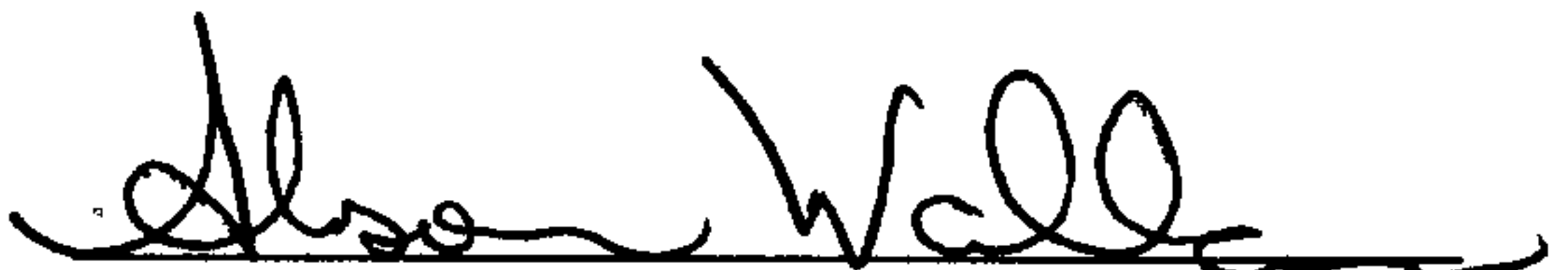
AFFIDAVIT

Further the affiant sayeth not.

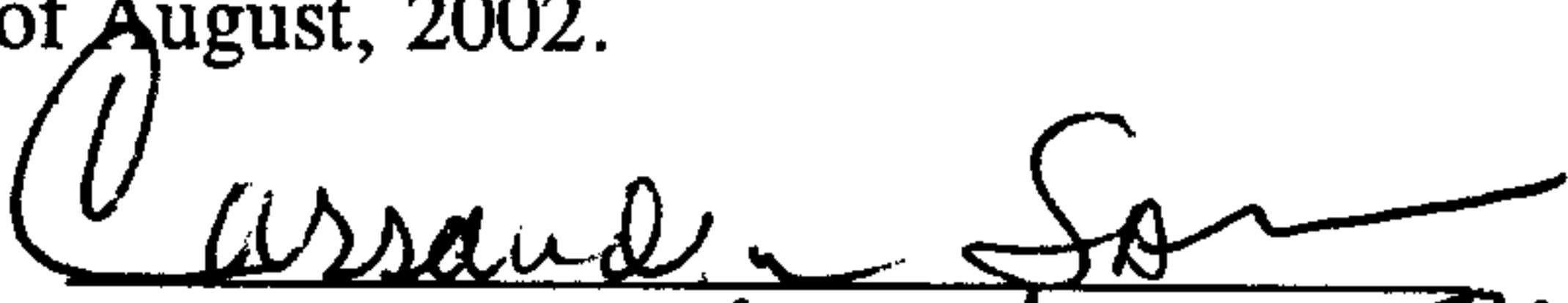

EXHIBIT "A"

Parcel I

A tract of land situated in the SE 1/4 of the SW 1/4 of SW 1/4 of Section 16, Township 19 South, Range 2 West, Shelby County, Alabama, and more particularly described as follows:

Begin at the SW corner of said 1/4 - 1/4 Section; thence run in a northeasterly direction along the diagonal line between the SW corner and the northeast corner of said 1/4 - 1/4 section for a distance of 85.22 feet; thence an angle right of 30 degrees 52 min. 46 sec. and run in a northeasterly direction along the north right of way line of a paced county road, a distance of 283.67 feet; thence an angle left of 139 deg. 37 min 12 sec. and run northwest a distance of 172.59 feet to the southeast right of way line of Valleydale Road; thence an angle left of 74 deg. 42 min 27 sec. and run southwest along said right of way a distance of 275 feet to the south line of the SW 1/4; thence an angle left of 130 deg. 46 min 15 sec. and run east along said South line a distance of 1.82 feet to the point of beginning; being situated in Shelby County, Alabama.

Less and except:

For point of reference beginning at the SW corner of the SE 1/4 of the SW 1/4 of Section 16, Township 19 South Range 2 West, Shelby County, Alabama and run North 43 deg. 12 min. 35 sec. E. 85.43 feet to an iron pin; thence N 74 deg. 11 min 23 sec. E. 241.31 feet to an iron pin and the beginning; thence N 44 deg. 15 min. 00 sec. W. 75.70 feet to an iron pin; thence S 65 deg. 28 min. 55 sec. E. 102.85 feet to an iron pin; thence S 74 deg. 11 min. 23. sec. W. 42.36 feet to the point of beginning.
