- 5. This Amendment may be executed in any number of counterparts, with the same effect as if all parties hereto had signed one and same document. All counterparts shall be construed together and shall constitute as the same Amendment.

- 6. The effective date of this Amendment shall be the last date on which it is executed by and Present Member.
- 7. Sophia Tamburello is hereby admitted as a member of Bernie's L.L.C., for all purposes and Sophia Tamburello hereby agrees to be bound by all terms of Operating Agreement as amended.
