STATUTORY WARRANTY DEED

THIS STATUTORY WARRANTY DEED is executed and delivered on this 17th day of September, 2002 by BARBARA M. TICKLE, a married woman, joined by her husband, T. CHARLES TICKLE (collectively, "Grantor"), in favor of THE WATER WORKS AND SEWER BOARD OF THE CITY OF BIRMINGHAM, a public corporation ("Grantee").

KNOW ALL MEN BY THESE PRESENTS that, for and in consideration of the sum of Ten Dollars (\$10.00), in hand paid by Grantee to Grantor and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Grantor, Grantor does by these presents, GRANT, BARGAIN, SELL and CONVEY unto Grantee that certain real property (the "Property") situated in Shelby County, Alabama, which is more particularly described in Exhibit A attached hereto and incorporated herein by reference.

The Property is conveyed subject to the following (collectively, the "Permitted Exceptions"):

- 1. Ad valorem taxes due and payable October 1, 2002 and for all subsequent years thereafter.
- 2. Fire district dues and library district assessments for the current year and all subsequent years thereafter.
- 3. Restrictions, covenants and conditions as set out in access easement agreement recorded in Inst. No. 1993-25945 in the Office of the Judge of Probate Office of Shelby County, Alabama (the "<u>Probate Office</u>")
- 4. Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including rights set out in Deed 323 page 560 in the Probate Office.
- 5. Fence encroachments onto and off of the land as shown on survey by K. B. Weygand dated July 9, 1993 and August 10, 1993 and areas of land shaded on said Weygand surveys as being subject to possible adverse claims of title.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns, forever, subject, however, to the Permitted Exceptions.
