Know All Men by These Presents: That in consideration of **One hundred forty two thousand seven hundred and no/100 (\$142,700.00)** to the undersigned grantor **J. B. Nix Home Builders, Inc.**, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **J. B. Nix Home Builders, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Brian Bone and Dawn L. Bone** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
