) **WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **Seventy-Six Thousand & 00/100 Dollars (\$76,000.00)** and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, **Jacquelyn McClain Holifield, a single person and sole beneficiary under the Last Will and Testament of Vincent Holifield, deceased, Probate Case No. 40-274, in the Probate Office of Shelby County, Alabama,** hereinafter called "Grantors", do hereby GRANT, BARGAIN, SELL AND CONVEY unto **Brian A. Dillon and Christy L. Hadidon, single persons,** hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama, to wit:**

Lots 7 and 8, Block 92, according to J. H. Dunstan's Map of the Town of Calera, Alabama. Situated in Shelby County, Alabama.

Note: This property does not constitute homestead property for the Grantor.

Note: Jacquelyn McClain Holifield and Jacquelyn Holifield are one and the same person.

TO HAVE AND TO HOLD to the said Grantees in fee simple forever, for and during their joint lives and upon the death of either of them, then the survivor in fee simple, and to the heirs of such survivor forever, together with every contingent remainder and right of reversion.
