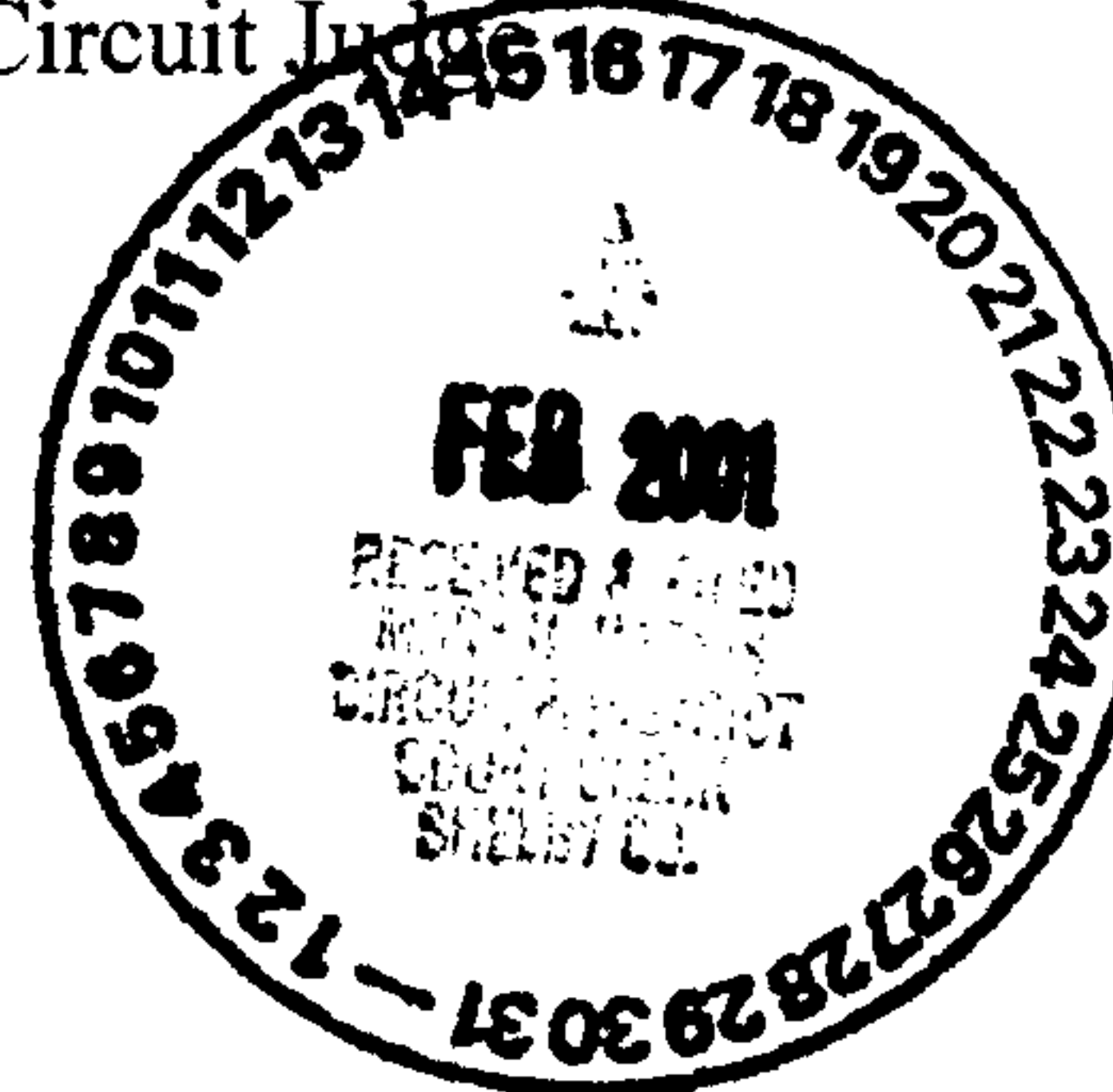
The Clerk of this Court is hereby ordered and directed to make and record a Certificate showing the transfer of such lien from the real property to the aforesaid security and to mail a


