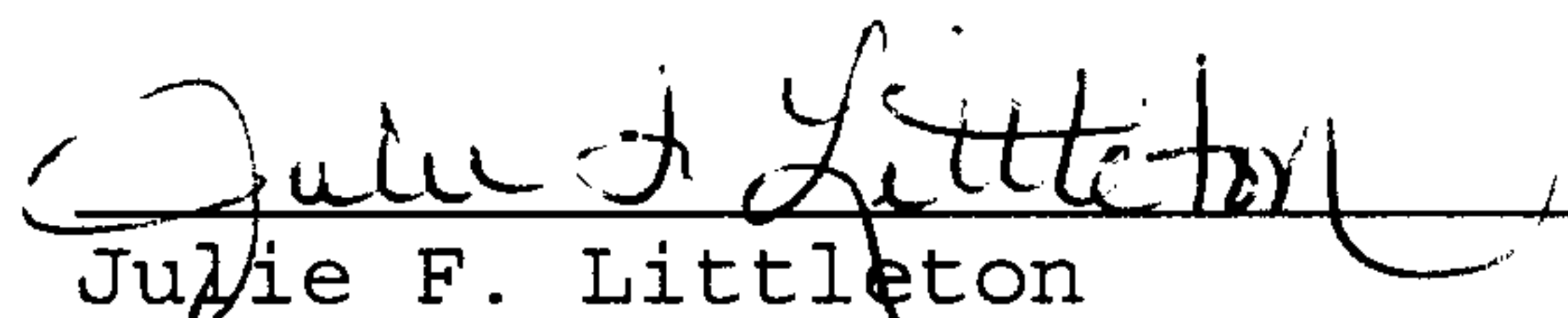
such survivor forever, together with every contingent remainder and right of reversion.

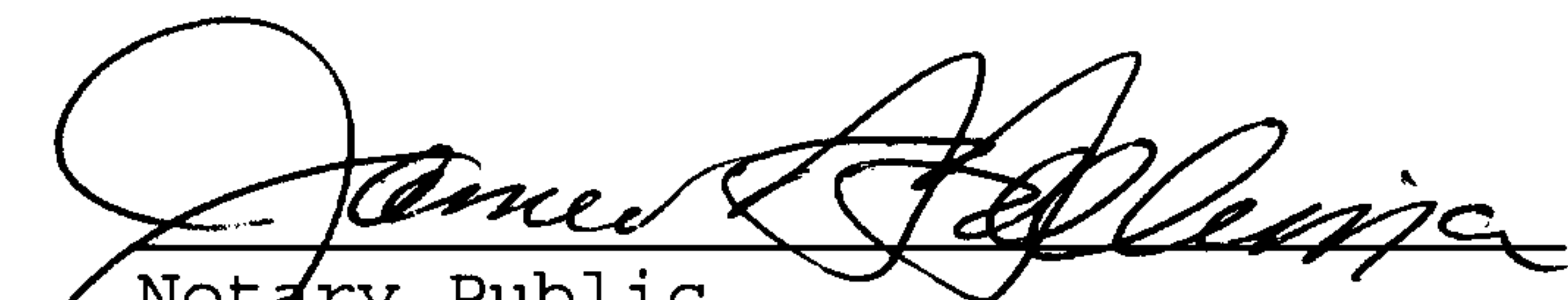
