Any and all references in the Assignment to the amount of the principal indebtedness evidenced by the Note and secured by the Assignment shall be deemed to mean the indebtedness owing by the Assignor to the Assignee in the principal sum of One Million Four Hundred Sixty-Five Thousand and No/100 Dollars (\$1,465,000.00) (instead of \$816,244.49) and, in furtherance of the foregoing, the words "Eight Hundred Sixteen Thousand Two Hundred Forty-Four and 49/100 Dollars" and the number "\$816,244.49" are deleted in all places where such words or numbers are used in the Assignment, and, in their respective places, the words "One Million Four Hundred Sixty-Five Thousand and No/100 Dollars" and the number "\$1,465,000.00" are hereby substituted in lieu thereof.
- 2. Any and all references in the Assignment to the term "Note" shall be deemed to mean that certain Amended and Restated Promissory Note in the principal amount of One Million Four Hundred Sixty-Five Thousand and No/100 Dollars (\$1,465,000.00), dated as of October 4, 2002, made by Assignor, payable to the order of Assignee, and presently held by Assignee, together with any and all extensions, revisions, modifications, amendments, substitutions, or renewals thereof at any time made, and any supplemental note or notes increasing the indebtedness evidenced thereby.
- 3. Except as hereinabove expressly amended, the terms of the Assignment are hereby ratified and affirmed.
