According to Rodney Y. Shiflett survey, dated 4/10/99. and as a further inducement for Castle Mortgage Corporation to make said mortgage.

NOW, THEREFORE, premises considered and the payment of \$1.00 to him in hand paid by said <u>Castle Mortgage Corporation</u> the receipt whereof being hereby acknowledged, the undersigned ACIPCO Federal Credit Union does, by these presents, make, declare and confirm that the said mortgage above specifically described and indentified to be, and the same is second, subordinate, subservient, subject and inferior to the lien of the above mortgage to Castle Mortgage Corporation in all things and in all respects without reservation.
