Part of the SE 1/4 of NW 1/4 and a part of the SW 1/4 of NW 1/4 of Section 12, Township 17 South, Range 1 East, and described as follows:

Commence at the SW corner of the SE 1/4 of NW 1/4 of Section 12, Township 17 South, Range 1 East, thence N 88 degrees 07' E along the South line of said 1/4 1/4 sections 1653.36 feet; thence N 2 degrees 30' W, 909.00 feet to the point of beginning of tract herein described; thence continue along the last named course 422.00 feet; thence S 88 degrees 05' West, 332.02 feet; thence S 25 degrees 26' E, 195.00 feet; thence S 62 degrees 03' W, 130.00 feet; thence S 21 degrees 04' E, 389.13 feet to the Northerly right of way line of a public road, said point being on a curve to the right having a central angle of 143 degrees 33' a radius of 50.00 feet; thence North and Easterly along the arc of said curve 125.27 feet; thence N 46 degrees 26' E 265.72 feet to the point of beginning.
