Commence at the SE corner of the NE 1/4 of the SW 1/4 of Section 17 Township 22 South, Range 1 West, Shelby County, Alabama, said point being the POINT OF BEGINNING, thence South 00 degrees 20 minutes 08 seconds West along the 1/4-1/4 line, a distance of 284.89 feet to a point, said point lying on the Northerly R.O.W. of the Heart of Dixie Railroad (100 feet R.O.W.) that has been abandoned, said point being the beginning of a non-tangent curve to the right, having a radius of 904.97 feet, a central angle of 46 degrees 07 minutes 16 seconds and subtended by a chord which bears South 87 degrees 04 minutes 52 seconds West, and a chord distance of 708.96 feet; thence along the arc of said curve and said R.O.W. a distance of 728.47 feet; thence North 00 degrees 01 minutes 04 seconds West and leaving said R.O.W. a distance of 1,031.91 feet; thence North 88 degrees 48 minutes 59 seconds east a distance of 714.43 feet; thence South 00 degrees 20 minutes 08 seconds West along the 1/4-1/4 line a distance of 725.69 feet to the POINT OF BEGINNING.
