SPECIFIC POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, DONNA M. HECKLINSKI, a legal resident of Shelby County, State of Alabama, do hereby nominate, constitute, and appoint, my husband, DONALD J. HECKLINSKI, as my true and lawful attorney-in; fact for me and in my name, place, and stead, and for my use and benefit:

GIVING AND GRANTING unto my said attorney-in-fact full power and authority to do and perform every act necessary, requisite, or proper to be done in and about the premises as fully as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney-in-fact shall lawfully do or cause to be done by virtue hereof.

This power of attorney shall not be affected by my disability, incompetency, or incapacity. If, following execution of this power of attorney, a court of our domicile appoints a guardian, curator, or other fiduciary charged with the management of all of my property, or all such property except specified exclusions, the court shall appoint my attorney-in-fact, DONALD J. HECKLINSKI, except for good cause or disqualification.

This specific power of attorney shall be effective for a period of thirty (30) days after execution hereof.
