

## Restated Articles of Incorporation

# SpudRay Adaptive Aquatics, Inc.

A non-profit corporation

Pursuant to the provisions of the Alabama Non-Profit Business Corporation Act, The undersigned hereby adopts the following restated Articles of Incorporation:

#### Article | - Name

The name of the corporation is SpudRay Adaptive Aquatics, Inc. and will be renamed to Adaptive Aquatics, Inc.

## Article | - Duration

The duration of the corporation is perpetual.

## Article III - Purpose

The corporation has been organized to be dedicated to the introduction, teaching, and advancement of adapted water skiing for children and adults with physical disabilities.

## Article IV - Members

The corporation has no members.

## Article V - Registered Office / Agent

## Article IX - Federal Tax ID Number

The purposes for which Adaptive Aquatics is organized are exclusively religious, charitable, literary and educational within the meaning of section 501c-3 of the Internal Revenue Code of 1986 or the corresponding provision of future United State Internal Revenue Law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501c-3 of the Internal Revenue Code of 1986 or the corresponding provision of future United State Internal Revenue Law.

Any provision, not inconsistent with the law, for the regulation of the internal affairs of the corporation, including any provision of distribution of assets on dissolution or final liquidation. Upon the dissolution of the organization, assets shall be distributed of one or more exempt purposes within the meaning of section 501c-3 of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, sate, or local government of a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.


