EXHIBIT "A"

Legal Description of Property

A parcel of land situated in the SE 1/4 of the NW 1/4, and the SW 1/4 of the NW 1/4 of Section 25, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

Commence at the SE corner of the said SE 1/4 of the NW 1/4; thence run in a Southwesterly direction along the South boundary of the said SE 1/4 of the NW 1/4 a distance of 1231.25 feet thence turn an angle of 104 deg. 15 min. 45 sec. to the right and run in a Northerly direction distance of 427.01 feet to the point of beginning; thence in the same Northerly direction a distance of 177.68 feet; thence turn an angle of 92 deg. 51 min. 03 sec. to the left and run in a Southwesterly direction a distance of 320.28 feet to the Northeast corner of U. S. Highway 31 right of way; thence turn an angle of 86 deg. 44 min. 47 sec. to the left and run Southerly along said right of way a distance of 159.67 feet to the Southeast corner of said right of way; thence turn an angle of 90 deg. 01 min. 49 sec. to the left and run in an Easterly direction a distance of 321.01 feet to the point of beginning; being situated in Shelby County, Alabama.
