

Legal description:

Commence at the Northwest corner of the Southwest Quarter of the Northeast Quarter of Section 11. Township 24 North. Range 13 East; thence South 87 degrees 57 minutes 16 seconds East along the North line of said 1/4-1/4 section and run 1071.48 feet; thence South 02 degrees 02 minutes 44 seconds West and run 215.74 feet; thence South 26 degrees 59 minutes 29 seconds West and run 195.84 feet to the Point of Beginning; thence continue along the last described course 147.41 feet; thence South 56 degrees 06 minutes 00 seconds East and run 242.79 feet to a point on the Westerly right of way line of County Road No. 67, said point being on a curve to the left having a central angle of 08 degrees 50 minutes 12 seconds and a redius of 701.94 feet; thence along the chord of said curve North 21 degrees 37 minutes 03 seconds East and run a chord distance of 108.15 feet to the end of said curve; thence along said right of way line North 17 degrees 11 minutes 57 seconds East and run 107.61 feet; thence North 72 degrees 48 minutes 03 seconds West and run 218.36 feet back to the Point of Beginning, Shelby County, Alabama.
