EXHIBIT "A"

PARCEL I

A parcel of land situated in the Northwest % of the Southeast %, Section 25, Township 19 South, Range 1 West, Shelby County, Alabama, more particularly described as follows:

Commence at the Southwest corner of the Northwest ¼ of the Southeast ¼, Section 25, Township 19 South, Range 1 West; thence run North along the West boundary of said ¼ - ¼ section 1154.14 feet to a point on the Southern right of way of U.S. Highway #280; thence turn 92°57′45" right and run 370.07 feet along said right of way to the point of beginning; thence continue along said right of way 150.0 feet; thence turn 87°02′15" to the right, leaving said right of way and run 1128.66 feet to a point on the Southern line of said ¼ - ¼ section; thence turn 90°09′19" to the right and run West along the Southern line of said ¼ - ¼ section 149.80 feet; thence turn 89°50′41" to the right leaving said line and run 1136.02 feet to the point of beginning.
