THIS CORRECTIVE STATUTORY WARRANTY DEED is executed and delivered on this 30th day of October, 2002 by GREYSTONE DEVELOPMENT COMPANY, LLC, an Alabama limited liability company ("Grantor"), in favor of PROCTOR AND SON'S BUILDERS, INC. ("Grantee").

WHEREAS, Grantor and Grantee desire to enter into this Corrective Statutory Warranty Deed in order to properly reflect and correct the legal description of the Property.

## NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Ten Dollars (\$10.00), in hand paid by Grantee to Grantor and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Grantor, Grantor does by these presents, GRANT, BARGAIN, SELL and CONVEY unto Grantee the Property situated in Shelby County, Alabama described as follows:

Lot 203-A, according to the Resurvey of Lots 201, 202 and 203, Greystone Legacy, 2nd Sector, as recorded in Map Book 28, Page 20, in the Probate Office of Shelby County, Alabama.

The Property is conveyed subject to the following:

- 1. Ad valorem taxes due and payable October 1, 2002, and all subsequent years thereafter.
- 2. Library district assessments for the current year and all subsequent years thereafter.
  - 3. Mining and mineral rights not owned by Grantor.
  - 4. All applicable zoning ordinances.
- 5. The easements, restrictions, reservations, covenants, liens, assessments, agreements and all other terms and provisions of the Greystone Legacy Declaration of Covenants, Conditions and Restrictions dated as of December 1, 1999 and recorded as

- 7. Subject to the provisions of Sections 6.04(a), 6.04(b) and 6.05 of the Declaration, minimum building setback requirements for selling, as defined in the Declaration, to be constructed, erected, placed or maintained on the Property shall be as follows:

(i)	Front Setback:	50_	_ feet;
(ii)	Rear Setback:	50	feet;
(iii)	Side Setbacks:	15	feet.

The foregoing setbacks shall be measured from the property lines of the Property.
