Part of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 1, Township 20 South, Range 2 West, being more particularly described as follows:

Commence at the NE corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 1, Township 20 South, Range 2 West; thence run in a Southerly direction along the East line of said  $\frac{1}{4}$ - $\frac{1}{4}$  section for a distance of 364.35 feet to the point of beginning (said point monumented on the surface by a  $\frac{1}{2}$ " capped iron rebar; M.L. Welch #15460); thence continue along the last described course for a distance of 120.0 feet to a point (said point monumented on the surface by a  $\frac{1}{2}$ " capped iron rebar; M.L. Welch #15460); thence turn an angle to the right of 90 degrees and proceed in a Westerly direction for a distance of 138.90 feet to a point. (said point monumented on the surface by a  $\frac{1}{2}$ " capped iron rebar; M.L. Welch #15460); thence turn an angle to the right of 90 degrees and proceed in a Northerly direction for a distance of 120.0 feet to a point (said point monumented on the surface by a  $\frac{1}{2}$ " capped iron rebar; M.L. Welch #15460); thence turn an angle to the right of 90 degrees and proceed in an Easterly direction for a distance of 138.90 feet to the point of beginning.
