PARTIAL RELEASE OF MORTGAGE

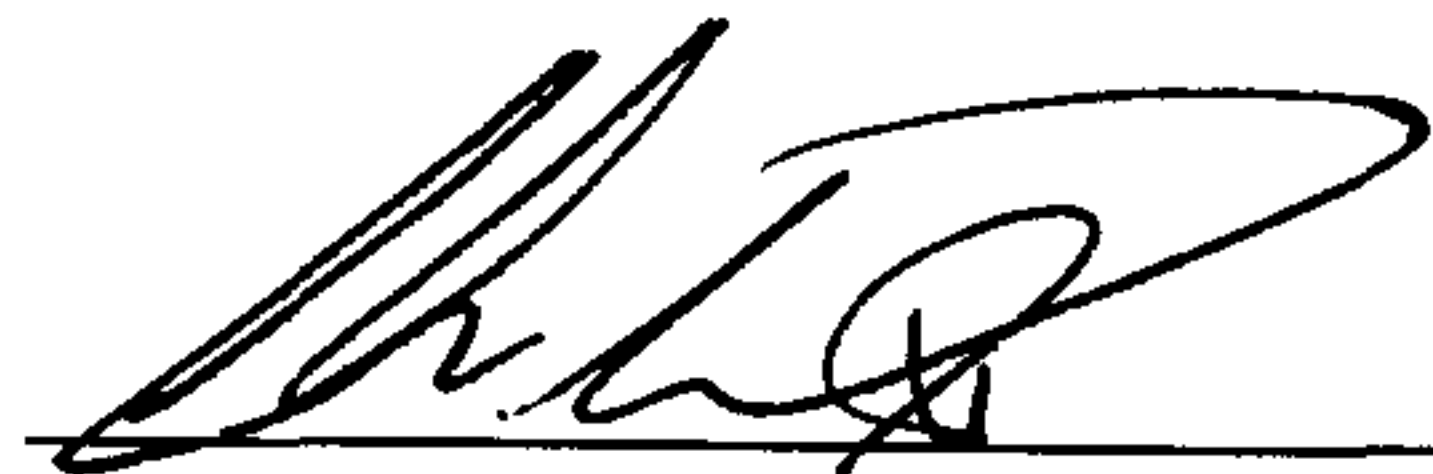
Parcel 17, according to the Map and Survey of Tanyard Branch Estates, Town of
