SUBORDINATION AGREEMENT

WHEREAS, under the terms of an Assignment of Mortgage FEBRUARY 13, 2001, and recorded in Real Volume 2001-29784, in the Office of the Judge of Probate of SHELBY County, Alabama, Irwin Union Bank and Trust Company (the "Lender") is the holder of record of a mortgage, covering that certain property in SHELBY County, Alabama, recorded in Real Volume 2001-11727, Page, ______ in the Office of the Judge of Probate of such county, executed by TINASCOX in favor of COMMUNITY BANK OF NORTERN VIRGINIA (the "Prior Mortgage"); and

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby subordinates the lien of the Prior Mortgage to the lien of the New Mortgage and declares that the New Mortgage shall be a first in priority lien on the property and shall be entitled to the same rights and privileges, both in law and equity, as it would have had if the New Mortgage had been executed, delivered and recorded prior to the Prior Mortgage.
