Now, Therefore, in consideration of the Premises, and the sum of ONE HUNDRED THIRTEEN THOUSAND NINE HUNDRED AND NO/100 (\$113,900.00) DOLLARS, cash in hand paid to the undersigned, namely: LAURA JEAN FETKO as Executrix of the Will and Estate of ELEANORE FETKO, deceased, the receipt of which is hereby acknowledged, the undersigned, in her capacity as Executrix of the Estate of ELEANORE FETKO, does by these presents, grant, bargain, sell and convey unto CHARLOTTE DRAPER; HALSA M. POSTEN and WILLIAM J. MATHIS, JR. (GRANTEES), as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama, to-wit:

And we do for ourselves and for our heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.

It is understood and agreed that wherever in this instrument the singular number is used, it applies to the plural if and when necessary and that when the plural is used, the plural likewise applies to the singular if and when necessary.
