FOR VALUABLE CONSIDERATION to the undersigned paid by the Grantee herein, the receipt of which is hereby acknowledged, the undersigned, CHASE MANHATTAN MORTGAGE CORPORATION a corporation, (hereinafter called the Grantor) has granted, bargained and sold, and does by these presents grant, bargain, sell and convey unto FEDERAL NATIONAL MORTGAGE ASSOCIATION, a corporation organized and existing under the laws of the United States, its successors and assigns, (hereinafter called the Grantee), the following described property situated in Shelby County, Alabama:

Being a part of the Southwest ¼ of the Southwest ¼ and the Southeast ¼ of the Southwest ¼ of Section 4, Township 20 South, Range 1 West, Shelby County, Alabama, and being described as follows: Begin at the Southwest corner of the Southeast ¼ of the Southwest ¼ of Section 4, Township 20 South, Range 1 West; thence proceed North along the West line of said ¼¼ Section a distance of 498.28 feet to an iron pin being the point of beginning; thence turn a field angle of 88 deg. 45 min. to the left and proceed a distance of 297.88 feet to an iron pin; thence turn an interior angle of 72 deg. 21 min. 40 sec. to the right and run a distance of 532.21 feet to an iron pin; thence turn an interior angle of 169 deg. 30 min. 31 sec. to the right and proceed a distance of 208.80 feet to an iron pin located on the Southerly right of way of Shelby County Highway No. 39; thence turn an interior angle of 88 deg. 53 min. 22 sec. to the right and proceed along the Southerly right of way of County Road No. 39 a distance of 56.61 feet to an iron pin; thence continue along the Southerly right of way of County Road #39 a distance of 262.81 feet to an iron pin located in a concrete monument; thence turn an interior angle of 99 deg. 44 min. 00 sec. To the right and proceed a distance of 296.26 feet to a concrete monument; thence turn an interior angle of 171 deg. 54 min. 14 sec. to the right and proceed a distance of 296.99 feet to the point of beginning being situated in Shelby County, Alabama.

The conveyance is made subject to unpaid taxes and assessments, if any, and to any outstanding rights of redemption from foreclosure sale.

No word, words, or provisions of this instrument are intended to operate as or imply covenants or warranty except the following: Grantor does hereby specially warrant the title to said property against the lawful claims of all persons claiming by, through or under the Grantor.

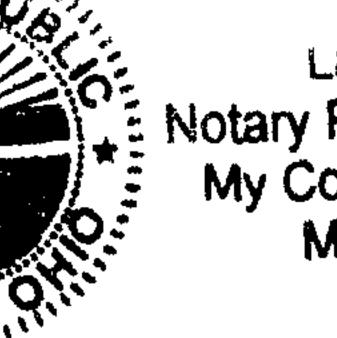
