KNOW ALL MEN BY THESE PRESENTS:

That in consideration of TEN DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

SAM J. IRVIN AND WIFE, LOLITA H. IRVIN

(herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto

SAM J. IRVIN AND LOLITA H. IRVIN, Trustees, or their successors in trust, under the IRVIN LIVING TRUST, dated December 10, 2002 and any amendments thereto

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:


The SW ¼ of the SE ¼ of Section 33, Township 19 South, Range 1 East, Shelby County, Alabama, LESS AND EXCEPT the following described property: Commence at the Northeast corner of the SW ¼ of the SE ¼ of Section 33, Township 19, Range 1 East, Shelby County, Alabama, and run South along the East line of said ¼ - ¼ Section a distance of 327.04 feet to the point of beginning; thence right 62 degrees 52 minutes and run a distance of 219.83 feet; thence left 62 degrees 52 minutes and run 951.52 feet to the South line of said ¼ - ¼ Section; thence left 90 degrees and run a distance of 195.04 feet along the South line of said ¼ - ¼ Section to the Southeast corner of said ¼ - ¼ Section; thence left and run North along the East line of said ¼ - ¼ a distance of 1051.78 feet, more or less, to the point of beginning. Subject to taxes, restrictions, rights-of-way, exceptions, conditions and easements of record.


TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons.


