STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to the undersigned, GEORGE ELWIN HUGHES AND JAMES NEIL HUGHES, AS PERSONAL REPRESENTATIVES OF THE ESTATE OF BETTY H. HUGHES, DECEASED (hereafter collectively referred to as the "Grantors"), in hand paid by GEORGE ELWIN HUGHES AND JAMES NEIL HUGHES, TRUSTEES OF HENRY'S SPECIAL NEEDS TRUST ESTABLISHED UNDER THE LAST WILL AND TESTAMENT OF BETTY H. HUGHES, DATED DECEMBER 21, 2001 (hereafter collectively referred to as the "Grantees"), the receipt of which is hereby acknowledged, the said Grantors do, by these presents, grant, bargain, sell and convey unto the said Grantees the following described real property situated in Shelby County, Alabama, to-wit:

An undivided ½ interest in and to the following described property: A tract of land containing six (6) acres more or less and being a part of the original W. L. Hughes and wife Edna E. Hughes property as recorded in Deed Book 140, Page 320 in the office of the Judge of Probate of Shelby County, Alabama, described as follows: The East 285 feet of the following described property; Begin at the Northeast corner of Section 30, Township 19 South, Range 1 East, and run West along the North line of said Section, 630 feet; thence South to a point on the North side of the Right of Way of the Florida Short Route Highway which is 630 feet West of the East line of said Section; thence Northeasterly along the North line of said Right of Way to the East line of said Section 30, thence North along section line to the point of beginning.
