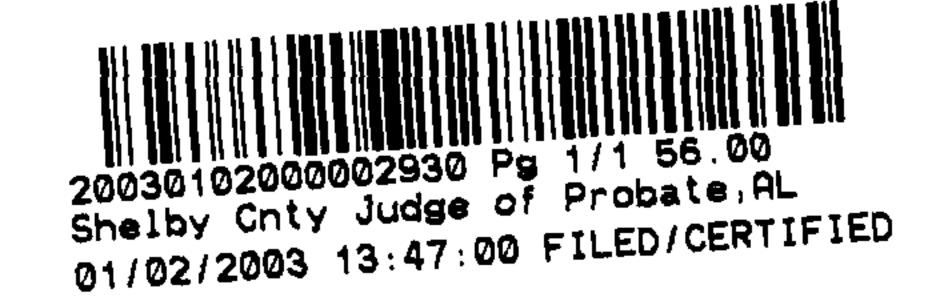

WARRANTY DEED
