KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Fifty-One Thousand Five Hundred Sixty and 00/100 (\$151,560.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **James L. Scott and Tommie A. Scott, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **William D. Callahan, and Stephanie M. Callahan, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 36, according to the survey of Park Forest Subdivision, 5th Sector, as recorded in Map Book 17, page 91, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.

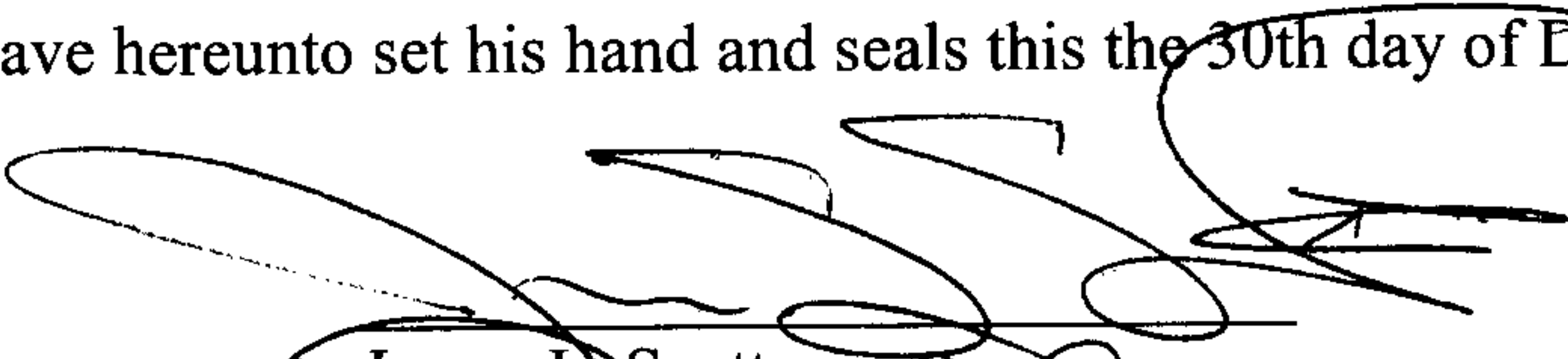
Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

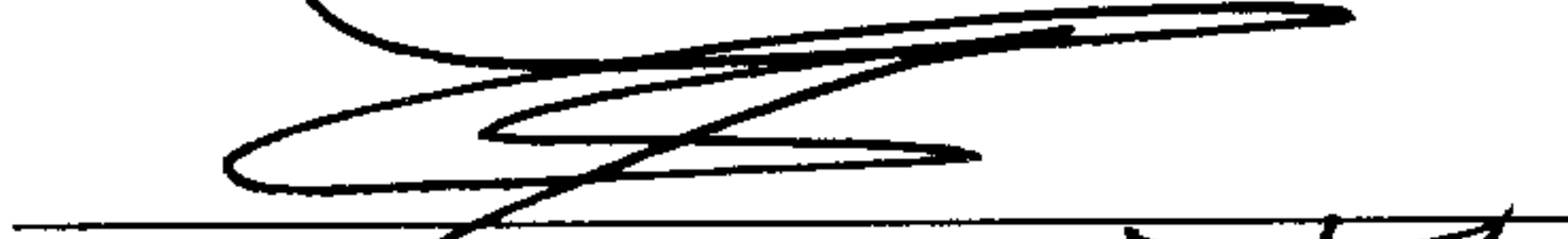
