Three Parcels of land situated in the East 1/2 of the East 1/2 of the Northeast Quarter of Section 19, Township 21 South, Range 1 West, Shelby County, Alabama, more particularly described as follows:

Begin at concrete monument found locally accepted to be the Northeast corner of said Section 19; thence run South along the East line of said Section 19 for a distance of 140.00 feet to an iron pin set; thence turn an angle to the right of 90 degrees, 39 minutes, 42 seconds and run in a Westerly direction parallel to the North line of said Section 19 for a distance of 311.16 feet to an iron pin set; thence turn an angle to the right of 89 degrees, 20 minutes, 18 seconds and run in a Northerly direction parallel to the East line of said Section 19 for a distance of 140.00 feet to an iron pin set on the North line of said Section 19; thence turn an angle to the right of 90 degrees, 39 minutes, 42 seconds and run in an Easterly direction along said North line for a distance of 311.16 feet to the point of beginning; said Parcel 1 containing 1.00 acres, more or less.

Together with and subject to a non-exclusive easement for ingress, egress and utility easements described as follows:

Commence at a concrete monument found locally accepted to be the Northeast corner of Section 19, Township 21 South, Range 1 West, Shelby County, Alabama; thence run North 89 degrees, 30 minutes, 52 seconds West along the North line of said Section 19 for a distance of 634.10 feet to an iron pin found; thence run South 00 degrees, 02 minutes, 15 seconds East for a distance of 436.24 feet to an iron pin found; thence run South 85 degrees, 38 minutes 08 seconds East for a distance of 444.98 feet to an iron pin found; thence run South 20 degrees, 53 minutes, 34 seconds East for a distance of 284.43 feet to a point; thence run North 73 degrees, 41 minutes, 38 seconds East for a distance of 20.16 feet to the point of beginning; thence run North 21 degrees, 59 minutes, 24 seconds West for a distance of 268.09 feet to a point; thence run North 24 degrees, 33 minutes, 12 seconds West for a distance of 108.96 feet to a point; thence run North 24 degrees, 12 minutes, 14 seconds East for a distance of 162.63 feet to a point; thence run North 00 degrees, 29 minutes, 08 seconds East for a distance of 65.75 feet to a point; thence run North 89 degrees, 30 minutes, 52 seconds West for a distance of 78.51 feet to the end of said easement.
