

WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of Two Hundred Two Thousand and 00/100 Dollars (\$202,000.00) to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Patrick Patronas and Amanda Patronas

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

\$191,900.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: 2003 ad valorem taxes not yet due and payable;

> (2)all mineral and mining rights not owned by the Grantors; and

(3)all easements, rights-of-way, restrictions, covenants encumbrances of record.
