MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that whereas, heretofore, on, to-wit: on November 14, 2001, Marion Rutherford executed a certain mortgage on property hereinafter described to First National Bank of Shelby County which mortgage is recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 2001-52843, Record of Mortgages; and
