

A parcel of land situated in the SE 1/4 of the SW 1/4 of Section 15, Township 22 South, Range 1 West, and the NW 1/4 of the NE 1/4 of Section 22, Township 22 South, Range 1 West in Shelby County, Alabama and being more particularly described as follows:

Commence at the SW corner of the SW 1/4 of the SE 1/4 of Section 15, Township 22 South, Range I West, said point being the point of beginning; thence S 01 deg. 31 min. 05 sec. W and along section line, a distance of 351.60 feet to a point, said point lying on the Northerly right of way line of County Highway #42 (80 feet right of way) said point also being the beginning of a non tangent curve to the left having a radius of 1209.04 feet a central angle of 14 deg. 38 min. 36 sec. and subtended by a chord which bears N 65 deg. 11 min. 58 sec. E and a chord distance of 308.16 feet; thence along the arc of said curve and said right of way a distance of 309.00 feet; thence N 59 deg. 28 min. 14 sec. E and along said right of way a distance of 437.45 feet; thence N 02 deg. 43 min. 08 sec. E and leaving said right of way a distance of 534.09 feet; thence N 89 deg. 13 min. 10 sec. W a distance of 1039.24 feet to a point, said point being the approximate center of Waxabatchee Creek; thence S 53 deg. 40 min. 26 sec. E and along said creek, a distance of 647.79 feet; thence S 90 deg. 00 min. 00 sec. W and leaving said creek a distance of 300.00 feet to the point of beginning. Being situated in Shelby County, Alabama.
