DECLARATION OF VACATION OF STREET

To the Mayor and Council of the City of Columbiana, Alabama.

Now comes the undersigned First Baptist Church of Columbiana, Alabama, hereinafter referred to as Owner, which presents the following Declaration pursuant to § 23-4-20, Code of Alabama 1975, as amended:

Owner is the owner of all of the property abutting the following described part of Lauderdale Street located within the corporate limits of the City of Columbiana, Alabama; it desires to vacate said part of Lauderdale Street, a sketch of which is attached hereto, and it does, by this Declaration, vacate the same:

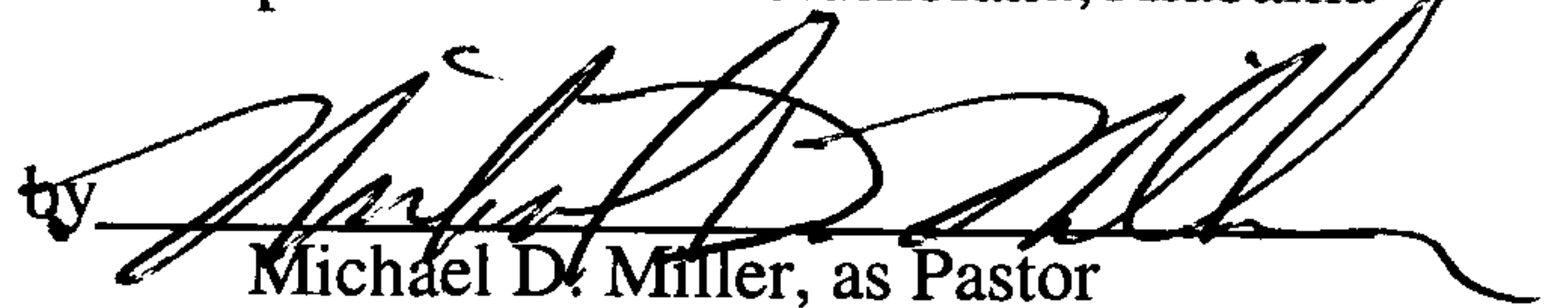
That portion of Lauderdale Street lying west of North Main Street and east of Lester Street

The above described part of Lauderdale Street has not been used by the public for over 20 years, and portions of the Owner's sanctuary and other buildings are constructed over it. The Owner desires to vacate the above described part of Lauderdale Street, to close the same, and to nullify the effect of the dedication of said part of Lauderdale Street to the use of the public. Such vacation will not deprive other property owners of such right as they may have to convenient and reasonable means of ingress and egress to and from their property.

Now, therefore, in consideration of the premises, Owner hereby requests that the City of Columbiana assent to the vacation of the above described part of Lauderdale Street and that a copy of the resolution assenting to such vacation be certified by the city clerk and presented to the Owner for attachment to the original of this Declaration, to be filed by the Owner for recording in the Office of the Probate Judge of Shelby County, Alabama, as provided by statute.

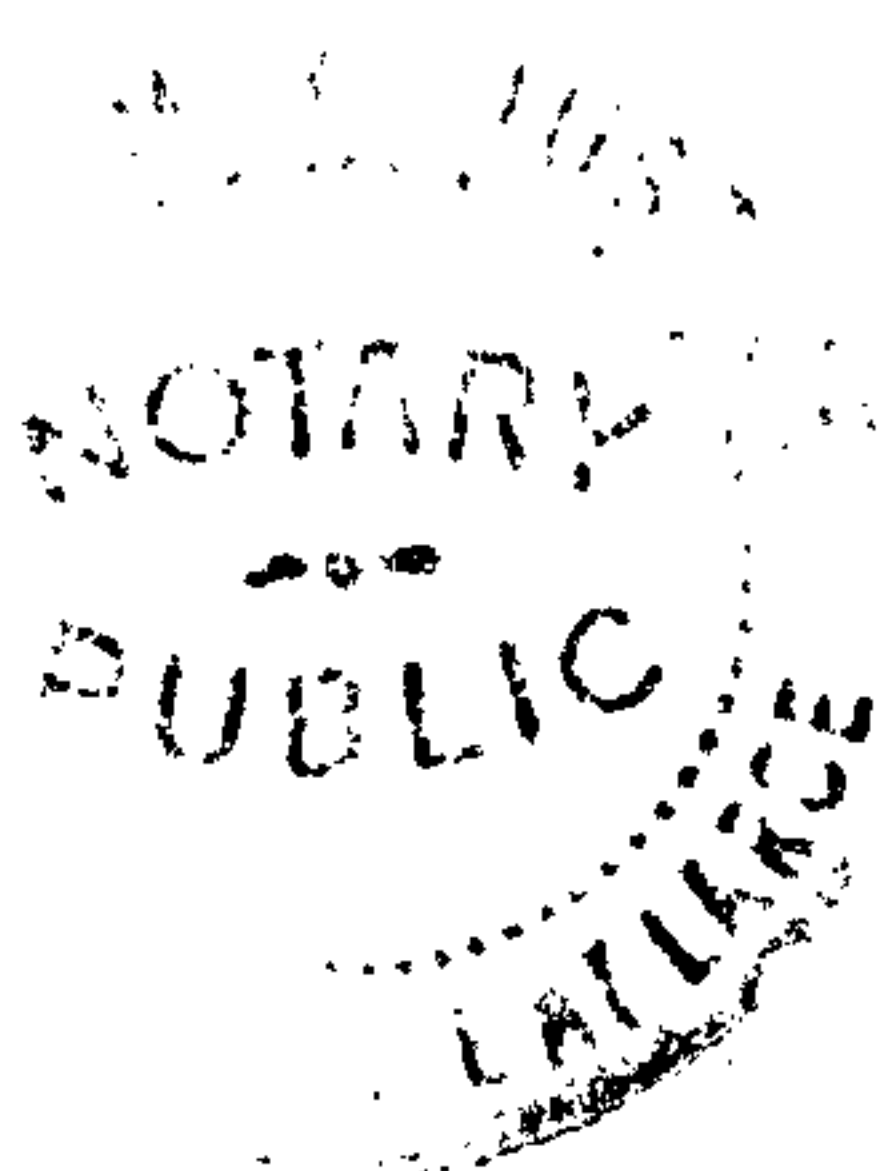

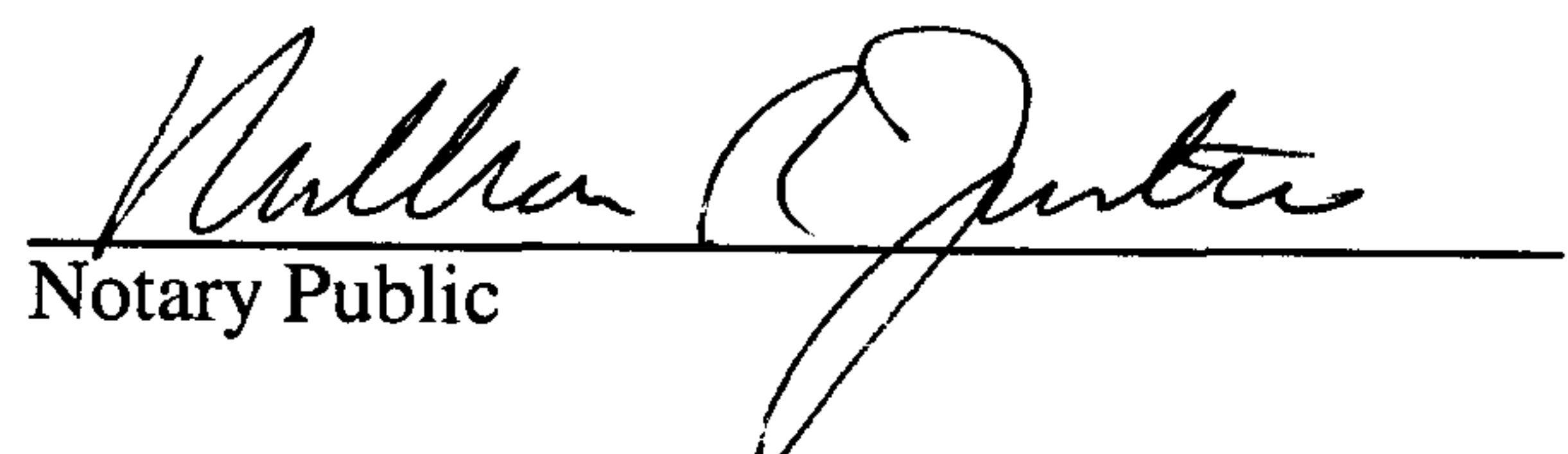
