

SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF SHELBY

THAT, WHEREAS, DAVID MARCUS CLEMENTS AND SPOUSE, TERESA BRYAN CLEMENTS, have an outstanding lien in favor of SOUTHTRUST BANK, dated the 14TH day of MARCH, 1994 recorded in the Probate Office of SHELBY COUNTY, Alabama, in Inst. # 1994/25431 on certain real estate described herein to secure an indebtedness of \$ 40,000.00 , and said lien is in full force and effect, and,
