
STATE OF ALABAMA JEFFERSON COUNTY

SUBORDINATION AGREEMENT



WHEREAS, JAMES RANDALL THOMAS AND DOREEN M. THOMAS, husband and wife, (hereinafter referred to as the "Borrowers" whether one or more), have applied to Alabama Telco Credit Union (hereinafter referred to as the "Lender") for a loan of money to be secured by a mortgage on the property hereinafter described; and

WHEREAS, Alabama Telco Credit Union, (hereinaster the "Lienholder"), has a lien on said property which would in the absence of this agreement be superior to the mortgage to be executed by the Borrowers to the Lender; and

The undersigned Lienholder hereby subordinates to the mortgage to be executed by the Borrowers to the Lender, all right, title and interest at law or equity of the undersigned Lienholder in and to the following described property situated in **Shelby County**, Alabama, to-wit:

Lot 26, according to the Survey of Valley Brook, Phase IV, as recorded in Map Book 14, Page 84, in the Probate Office of Shelby County, Alabama.

Alabama Telco Credit Union has a mortgage dated June 21, 2000 (second mortgage date) recorded in (junior mortgage) Alabama Telco Credit Union desires to subordinate it's interest in said mortgage without limitation to that certain mortgage granted to Alabama Telco Credit Union recorded in in 1857 2002/12/20058/5/10, in the probate office in Shelby County.
