

ARTICLES OF ORGANIZATION

Pursuant to the provisions of Title 10-12-1, et seq., Code of Alabama 1975, (the "Alabama Limited Liability Company Act") the undersigned hereby adopts the following Articles of Organization:

ARTICLE ONE

The name of the Limited Liability Company is **Claim Facilitators, LLC**.

ARTICLE TWO

The period of the Company's duration is perpetual.

ARTICLE THREE

The Limited Liability Company has been organized for the following purposes:
