

**CORPORATION FORM WARRANTY DEED**  
**JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP**


\$ 128,754.40 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.
