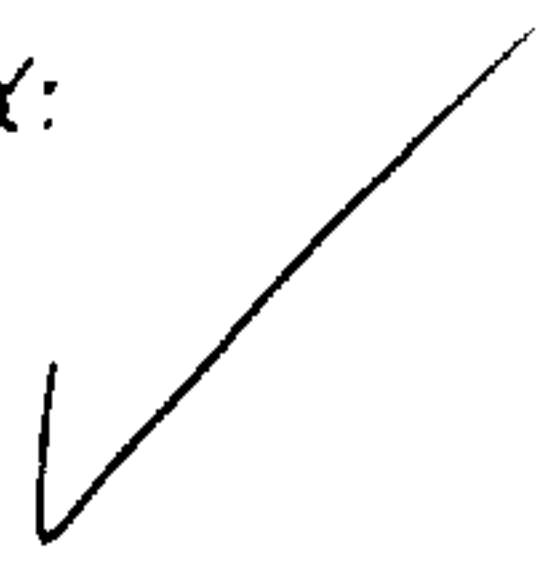

This Power of Attorney may be filed for record in any public office and shall expire 60 days from the date of execution.

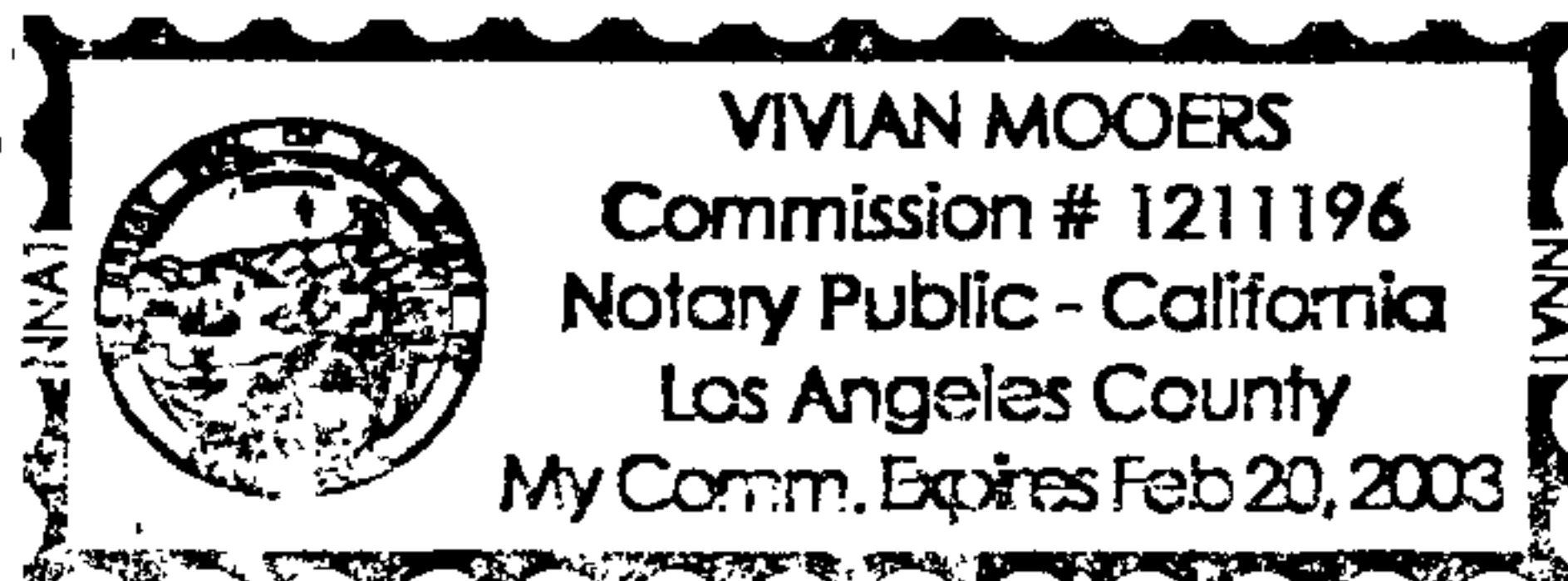
