**AN ORDINANCE DE-ANNEXING CERTAIN PROPERTY

BE IT ORDAINED by the City Council of the City of Hoover, Alabama, in regular meeting duly assembled, a quorum being present, as follows:


SECTION 1. Whereas petitions signed by R. Randall Chafin, Ass. Gen Mgr., The Water Works Board and the Sewer Board of the City of Birmingham presented to the City Clerk of the City of Hoover, Alabama, copies of which are attached hereto and marked **Exhibit "A"**, requesting the property described therein be de-annexed from the City of Hoover, said property being situated in Jefferson and Shelby County, Alabama, and described as follows:

SECTION 2. That the City Council of the City of Hoover, Alabama hereby finds that said property was annexed into the City limits of the City of Hoover and should now be de-annexed, and it is in the best interest of the City of Hoover that said property be de-annexed and the City of Hoover does hereby assent to the de-annexation of said property from the City of Hoover, Alabama.

SECTION 3. The City Clerk shall file a certified copy of this ordinance containing an accurate description of said de-annexed territory with he Probate Judge of Jefferson and Shelby County, Alabama, and also cause a copy of this ordinance to be published in a newspaper of general circulation in the City of Hoover.
