MORTGAGE MODIFICATION AGREEMENT
THIS MORTGAGE MODIFICATION AGREEMENT is executed this31st day of _JANUARY 2003 , by and between COLONIAL BANK, a state banking corporation (the "Mortgageee") and GENTRY O SHOWS & WIFE , JANICE D SHOWS
(the "Mortgagor"), as follows:
WITNESSETH:
WHEREAS, on <u>MARCH 6, 2000</u> , Mortgagor executed that certain Mortgage in favor of Mortgagee, which Mortgage was filed for recorded on the <u>30th</u> day of <u>MARCH</u> , <u>2000</u> , in the Office of the Judge of Probate of <u>SHELBY</u> County, Alabama, in Volume <u>2000</u> , Page <u>10204</u> (the "Mortgage"); and
WHEREAS, the indebtedness secured by the Mortgage has been renewed, extended or modified pursuant to <u>EQUITY LINE AGREEMENT</u> (the "Agreement"), entered into by and between Mortgagor and Mortgagee on even date herewith; and
WHEREAS, the Mortgagor has requested that the mortgagee increase the credit limit under the Agreement to $N/A$ and $0.00$ and $0.00$ ; and
WHEREAS, it is the intention of the parties that the lien of the Mortgage secure the indebtedness as renewed, extended or modified by the Agreement;
NOW, THEREFORE, in consideration of the Agreement, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the partie agree as follows:
This Modification is executed to modify the Mortgage to evidence the agreement of the parties that the lien of the Mortgage shall secure the indebtedness as amended and evidenced by the Agreement.
2. The Mortgage is modified to secure the credit limit of N/A and 00 /100 Dollars (\$ 0.00 ).
RATE MODIFICATION OF \$25,000.00 WITH NEW LOAN TERMS

- The Mortgagor hereby reaffirms the terms, conditions and provisions of the Mortgage which shall remain in full force and effect as expressly provided therein. The Mortgagor acknowledges that by execution of this Modification and the Agreement, Mortgagor does not intend to effect a novation or substitution, but rather intends to effect an extension and renewal or modification of the original indebtedness now evidenced by the Agreement.
- 4. Mortgagor agrees and acknowledges that the indebtedness as renewed, extended or modified by the Agreement and secured hereby, is valid, binding and enforable against the Mortgagor, and is not subject to any offsets, recoupment, deduction or other defenses of any kind or nature.
- 5. Except as modified hereby, the lien of the Mortgage shall remain in full force and effect.
