ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the <u>Code of Alabama</u>, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is McDougal Installation, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To engage in the business of installing flooring;

EIGHTH: The President shall have the authority to execute all deeds, mortgages, bonds and other contracts requiring a seal, and the President shall have authority to affix said seal to instruments requiring it, and attest the same.

NINTH: Jason McDougal shall serve the Corporation as Director until the first annual meeting of the Stockholders and/or until his successors are duly elected.

TENTH: The corporate powers shall be exercised by the President, except as otherwise provided by statute

or by these Articles of Incorporation. In furtherance and not in limitation of the powers conferred by state, the President is hereby expressly authorized:

- (a) To adopt, alter, amend and repeal the By-laws of the corporation, but By-laws so made by the directors may be altered or repealed by the directors or shareholders; and,

The Corporation may, and its By-laws, confer powers upon its Board of Directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon directors by statute.
