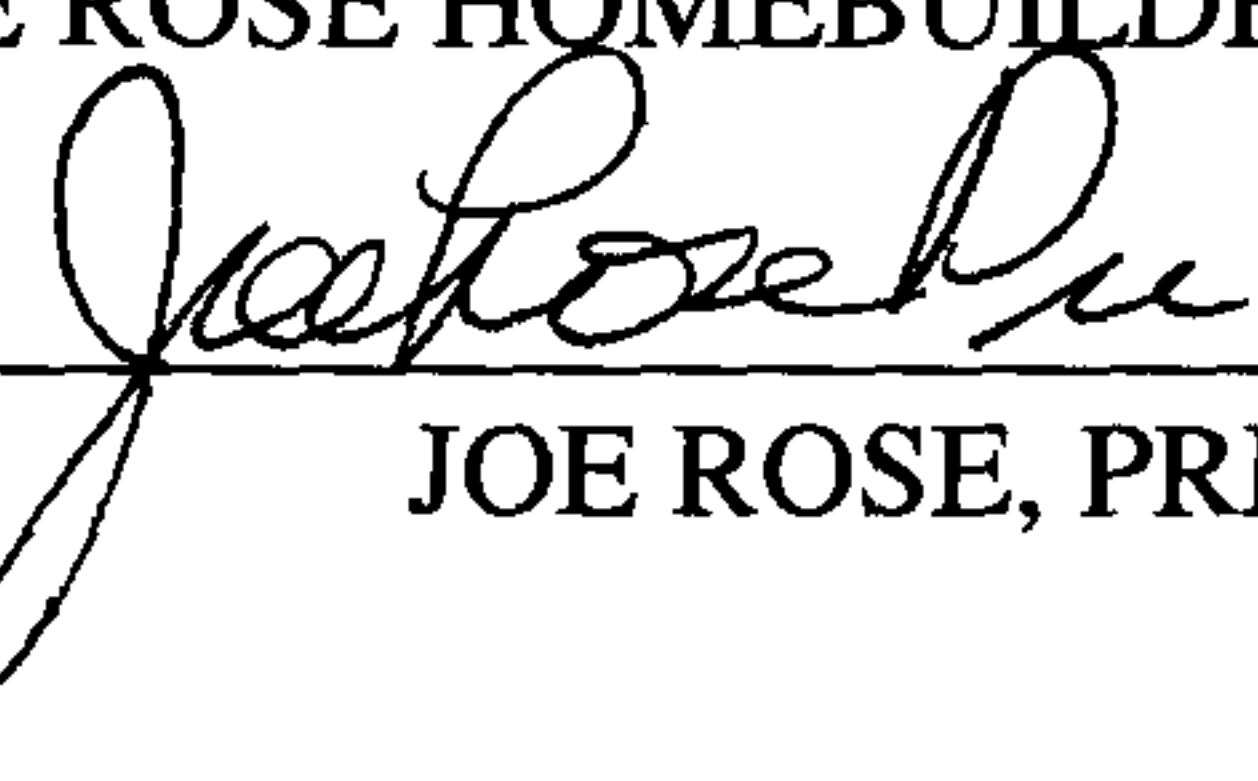


**TO HAVE AND TO HOLD** Unto the said GRANTEES, their heirs and assigns, forever.

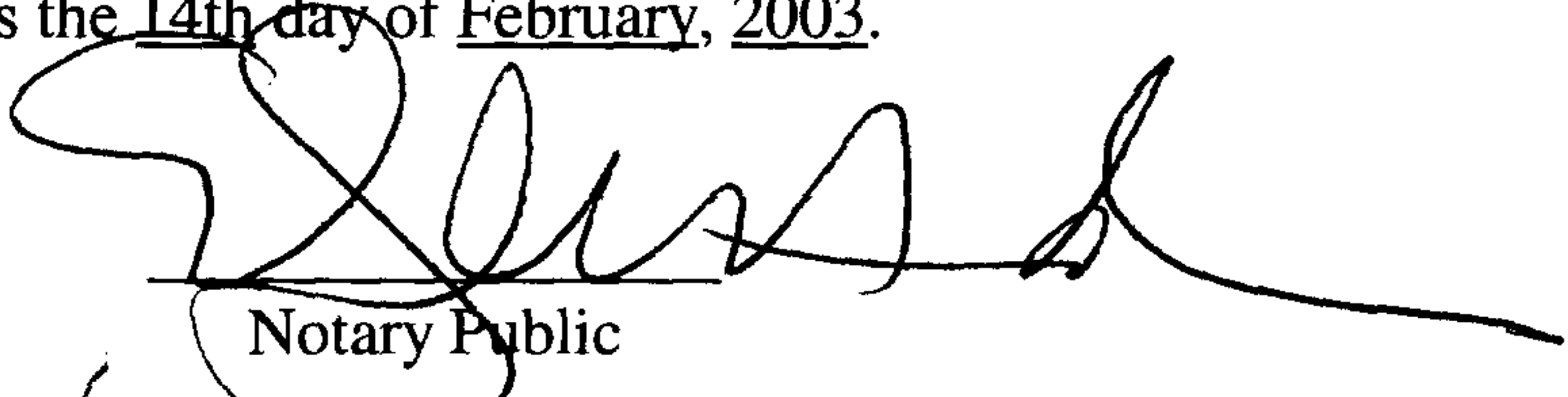
