That in consideration of One and no/100------------Dollars to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, **BOBBY BRASHER**, **unmarried** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **HEWITT L. CONWILL** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County**, **Alabama**, to-wit:

Commence at the Southwest corner of the SE 1/4 of the NW 1/4 of Section 11 South, Township 19, Range 2 East, Shelby County, Alabama; thence East 230.34 feet to the Westerly right-of-way of Hwy. 231 (100' R/W); thence North 22 deg. 00 min. 05 sec. East a distance of 50.21 feet to a point on said right-of-way, said point being the point of beginning of herein described parcel of land; thence North 86 deg. 38 min. 55 sec. West, a distance of 244.74 feet to a 3" open top pipe; thence North 03 deg. 36 min. 17 sec. East a distance of 205.37 feet to a 3/4" open top pipe; thence South 86 deg. 20 min. 33 sec. East a distance of 312.58 feet to a 1/2" capped rebar set on said right-of-way; thence South 22 deg. 00 min. 05 sec. West along said right-of-way a distance of 214.99 feet to the point of beginning.
