A parcel located in Shelby County, Alabama as follows:

Lots 5 and 6 Block 1, Park of Lot – 1 Block 3 and part of vacated Sonya Lane according to the Eckmann Subdivision as recorded in Map Book 3, page 144 in the probate office Shelby County, Alabama being more particularly described as follows: Begin at the most southerly corner of Lot 5 Block 1 of the Eckmann Subdivision; thence run in a northwesterly direction along the southwesterly line of Block One of said Eckmann Subdivision and its extension northwesterly for a distance of 434.72 feet; thence turn an angle to the right of 90 degrees and run in a northeasterly direction for a distance of 202.21 feet to a point on the southwesterly right-of-way line of U.S. Highway No. 31 South; thence turn an angle to the right of 90 degrees and run in a southeasterly along the southwesterly right-of-way line of U.S. Highway No. 31 south for a distance of 419.42 feet to the southeast corner of Lot 5 Block 1 Eckmann Subdivision; thence turn an angle to the right of 85 degrees 40 minutes 24 seconds and run in a southwesterly direction along the southeasterly line of said Lot 5 for a distance of 202.79 feet to the point of beginning. Said Parcel contains 84.811 square feet or 1.95 acres.
