**VERIFIED STATEMENT OF CLAIM OF LIEN**

THAT said AMWASTE claims a lien on the following real property situated in Shelby County, Alabama and on the buildings and improvements located thereon (the "Property"):


Lot 153, according to the Survey of Greystone Legacy,

THAT this lien is claimed, separately and severally, as to both the described land comprising the Property and the buildings and improvements located on the Property, to the extent of the entire lot or parcel. If said Property is not within a city or town this lien is claimed, pursuant to Section 35-11-217 Alabama Code (1975), separately and severally, as to the buildings and improvements located on the above-described real property, the land on which such buildings and property are situated, and one acre of land surrounding the buildings and improvements that is contiguous or adjacent.

THAT said lien is claimed to secure an indebtedness of \$491.57, including accrued finance charges, plus interest and attorneys' fees, from and after January 15, 2003, for waste disposal services and equipment in connection with the improvement of said Property.


THAT the name of said owners or proprietors of said Property are Todd P. and Patricia G. Murphy.
