VERIFIED STATEMENT OF CLAIM OF LIEN

THAT said AMWASTE claims a lien on the following real property situated in Shelby County, Alabama and on the buildings and improvements located thereon (the "Property"):

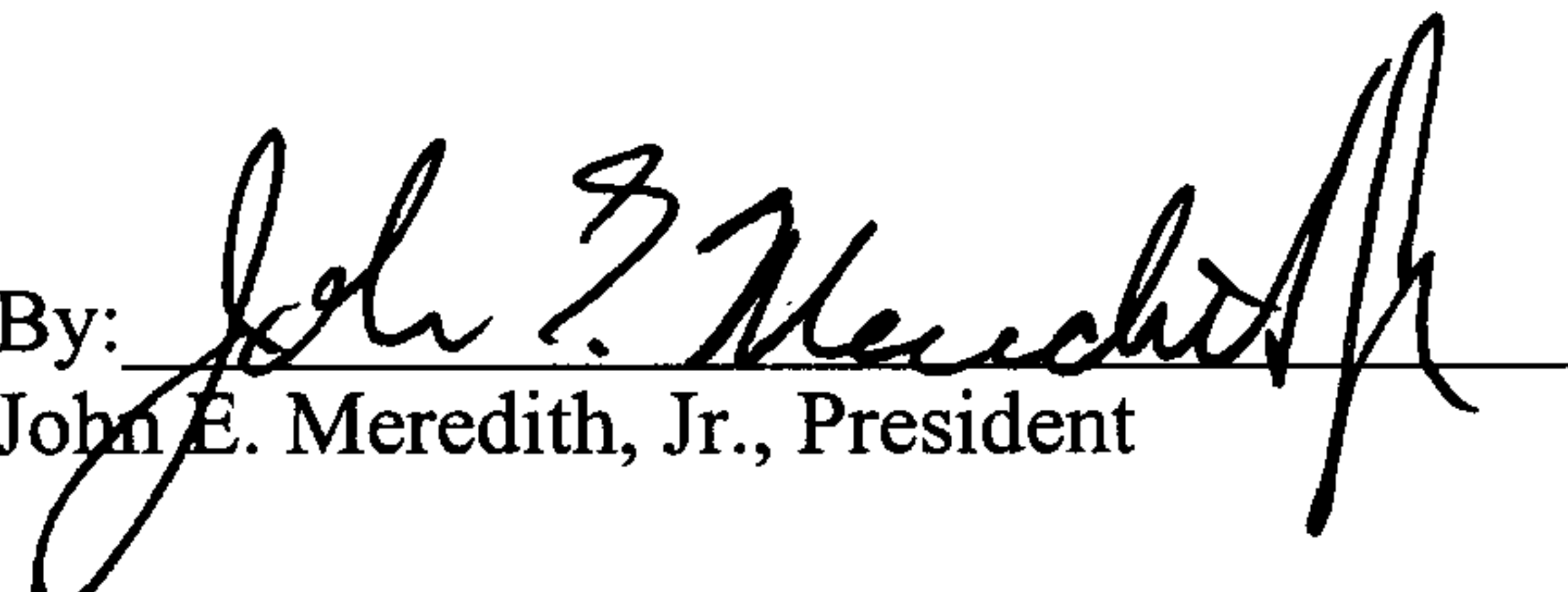
Lot 107, according to the Amended Map of The Cove of Greystone,

If said Property is not within a city or town this lien is claimed, pursuant to Section 35-11-217 Alabama Code (1975), separately and severally, as to the buildings and improvements located on the above-described real property, the land on which such buildings and property are situated, and one acre of land surrounding the buildings and improvements that is contiguous or adjacent.

THAT said lien is claimed to secure an indebtedness of \$827.30, including accrued finance charges, plus interest and attorneys' fees, from and after November 27, 2002, for furnishing waste disposal services and equipment in connection with the improvement of said Property.

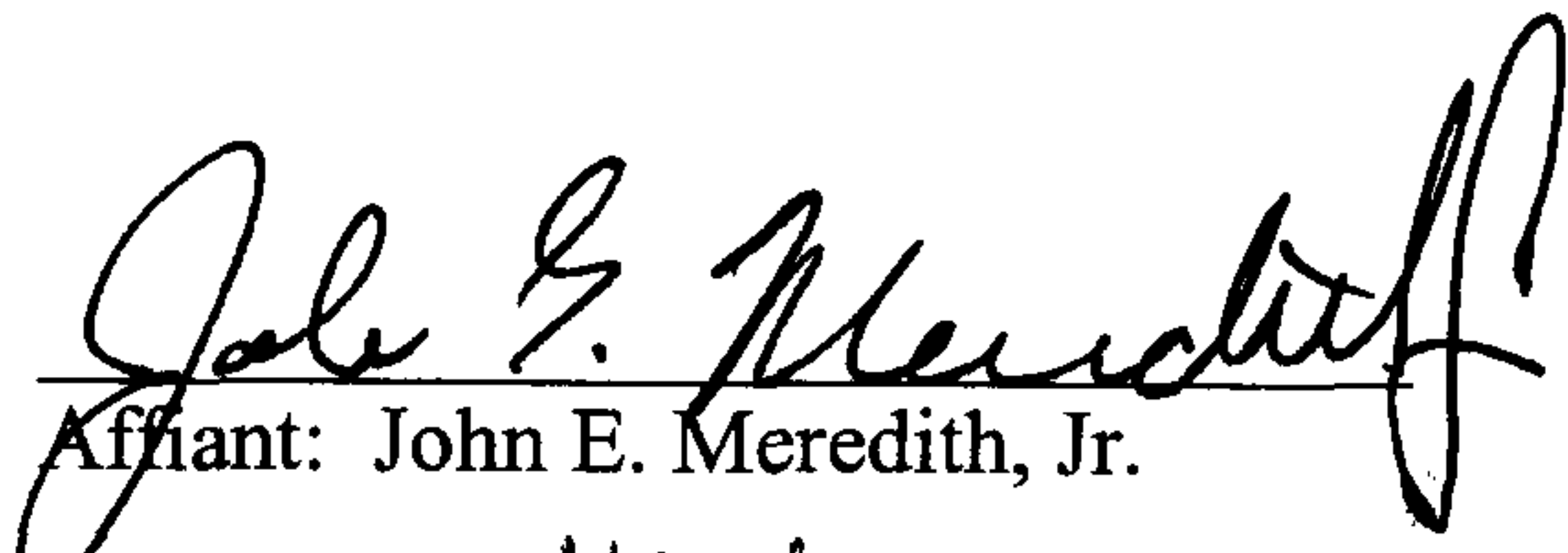
THAT the name of said owner or proprietor of said Property is Build America Homes, LLC.
