SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF SHELBY

This Subordination Agreement, made and entered into on this the Aday of FEBRUARY, 2003, by and between REGIONS BANK, as Party of the First Part, and SOUTHEASTERN MORTGAGE OF ALABAMA, LLC as Party of the Second Part.

WITNESSETH

THAT, WHEREAS, FRANK TRIVETT AND JOANNA TRIVETT, has an outstanding loan in favor of REGIONS BANK, as set forth in INSTRUMENT #1998-49031, in the Office of the Judge of Probate of SHELBY County, Alabama on that certain real estate located at 110 CARRIAGE DRIVE, MAYLENE, AL 35114 to secure an indebtedness of \$29,000.00 and said lien is in full force and effect; and,
