- B. The Mortgagor has executed in favor of the Mortgagee an Open End Credit, Future Advance Real Estate Mortgage and Security Agreement (the "Mortgage") recorded in Inst # 2001-03995/2002-17330, in the Probate Office of SHELBY County, Alabama. In addition to the other indebtedness described in the Mortgage, the Mortgage shall secure the payment of all advances heretofore or from time to time hereafter made by the Mortgagee to the Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding nor exceeding the Amended Credit Limit of FORTY FIVE THOUSAND------Dollars (\$ 45,000.00).

Except as specifically amended hereby, the Mortgage shall remain if full force and effect in accordance with its terms.
