A part of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 11, Township 21 South, Range 3 West, Shelby County, Alabama, more particularly described as follows:

Commence at the Southwest corner of Section 11, Township 21 South, Range 3 West, Shelby County, Alabama and run thence Easterly along the South line of said Section 11 a distance of 1,726.82 feet to a point; thence turn $70^{\circ}45'20''$ left and run Northerly a distance of 208.85 feet to a point; thence turn $00^{\circ}07'23''$ left and continue Northerly 124.85 feet to the point of beginning of the property being described; thence turn $84^{\circ}35'22''$ left and run Westerly 210.00 feet to a point on the Easterly right of way line of Highway No. 119; thence turn $90^{\circ}00'00''$ right and run Northerly along said right of way 210.00 feet to a point; thence turn $90^{\circ}00'00''$ right Easterly 210.00 feet to a point; thence turn $90^{\circ}00'00''$ right and run Southerly 210.00 feet to the point of beginning.
