

## ARTICLES OF ORGANIZATION

## P&C Properties, L.L.C.

Pursuant to the Code of Alabama, § 10-21-0, et seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

## **ARTICLE I**

# **NAME**

The name of the Limited Liability Company shall be "P & C Properties, L.L.C."

## **ARTICLE II**

## **DURATION**

The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Judge of Probate for Shelby County, Alabama until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization, or,
- (2) Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

### **ARTICLE III**

## **PURPOSES**

The Limited Liability Company has been organized for the following purposes:

To operate, conduct and maintain a business engaged in the acquisition, development, rental and management of real estate and to engage in any lawful business permitted under Alabama law as may be agreed upon by the Members.

## **ARTICLE IV**
